2 COMPULSORY LOCK CONTENT THRESHOLD

In terms of section 9(1) of the Proferential Procurement Regulations, 2011, and the Instruction Note issued by National Treasury on the "invitation and Evaluation of Bids based on a stipulated minimum threshold for local content and production for the **Textile, Clothing, Leather and Footwear** Sector," Transnet is required to set a stipulated minimum threshold be set for this RFQ.

2.1 Local Content Threshold

A Local Content threshold of **100%** [one hundred percent] will be required for all Goods to be manufactured by a successful Respondent Once off.

The successful Respondent is required to continuously update Declarations C, D and E with the actual values for the duration of the contract. In addition to what is stated above regarding Annexures D and E, please note that these declarations are to be submitted as part of the Essential Returnable Documents - See Section 2 of RFQ.

2.3 Challenges meeting the Local Content Threshold

Should, after the award of a Bid, the Supplier experience challenges in meeting the stipulated minimum threshold for Local Content, Transnet is required to inform the DTI accordingly in order for the DTI to verify the sircumstances and provide directives in this regard.

3 Broad-Based Black Economic Empowerment [B-BBEE]

Transnet fully endorses and supports the Government's Broad-Based Black Economic Empowerment Programme and it would therefore prefer to do business with local business enterprises who share these same values. As described in more dotall in the attached B-BBEE Claim Form Transnet will allow a "preference" to companies who provide a valid o-BBEE Verification Certificate.

The value of this bid is estimated to be below R 200 000 (all applicable taxes included) **OR** exceed R1 000 (all applicable taxes included); and therefore the **8**/20 ystem shall be applicable.

Respondents are required to complete Annexure A [the B-BECE Preference Point Claim Form] and submit it together with proof of their B-BBEE Status as stipulated in the claim Form in order to obtain preference points for their B-BBEE status.

Note: Failure to submit a valid and original B-BBEE certificate or a certified copy thereof at the Closing Date of this RFQ will result in a score of zero being allocated for B-BBEE.
