- Respondents failing to attend the compulsory briefing session and site inspection will be disqualified.
- Respondents without a valid RFQ document in their possession will not be allowed to attend the briefing session.
- **Reflective protective clothing and safety shoes must be worn when visiting the site. Without protective clothing and safety shoes respondents won't be allowed at the site meeting.**
- As the briefing session will be held in an operational area of Transnet, all people entering the premises may be subjected to a substance abuse test. This is a standard operational requirement for TFR, when entering any operational area in order that TFR may address the risk of injury. Any person that fails such test will not be permitted to enter the premises and thereby forfeits rights to be allowed access to the briefing session and will subsequently not be permitted to submit a bid for the tender.
