A compulsory clarification meeting with representatives of the Employer will take place on the 18 January 2017, at 10H00 at Transnet Freight Rail, 65 Little Street, Ermelo Depot Boardroom (-26.7104057, 30.1571023). There will be a compulsory site meeting thereafter which is 30km drive from Ermelo depot (more details will be clarified at meeting). Respondents must provide their own transport and accommodation/ protective clothing (without protective clothing responded will not be allowed to attend the site meeting)

- Respondents failing to attend the compulsory briefing session/site visit will be disqualified.
- FEL-3 Feasibility study report will be issued to those bidders who attended a compulsory briefing
- Respondents without a valid RFP document in their possession will not be allowed to attend the briefing session.
- As the proposed site visit may be held in an operational area of Transnet, all people entering the
  premises may be subjected to a substance abuse test. This is a standard operational requirement for
  TFR, when entering any operational area in order that TFR may address the risk of injury. Any person
  that fails such test will not be permitted to enter the premises and thereby forfeits rights to be allowed
  access to the briefing session and will subsequently not be permitted to submit a bid for the tender.
