#### GLENCOE A: 34 500 m2 ECX0198U

- All Transnet land above the Railway line from Biggar Street through to |Alice Street. This includes the embankments, the parking area, around the residential houses, around the old Trantel Bdg, and the relay room area.
- This is inclusive of the roadsides along the gravel road known as Alice Street 7up to the 3-line level crossing (Mast poleNo 119/17). Also inclusive of the triangle between the tracks M/P No 119/17 (crossing opposite c/o Alice and Francis Streets.
