1. Objectives

- 1.1. To create an environment for the staff at Transnet Freight Rail to experience the value of an on-site health and fitness facility and professional exercise programming from both a wellness and lifestyle perspective.
- 1.2. To make all Transnet Freight Rail staff members more aware of their personal health and wellness.
- 1.3. To implement lifestive management strategies that target lifelong health and wellness of all Transnet Freight Rail staff members.

2. Term

This Agreement with respect to full time biokineticist services shall commence on and with effect from the signature by both Parties.

The duration of the agreement with respect to full time biokineticist services between Transnet Freight Rail and Supplier will be from 1 March 2016 to 28 February 2018.

3. Roles of the Service Provider

3.1. To provide expertise in the day-to-day running and management of the Transnet Gym in terms of use of the equipment and facility, personal health and/or physical fitness assessment, personal training, counselling on healthy lifestyle management and physical activity habits, smoking, diet, nutrition, body

weight management, management of certain chronic diseases, such as high blood pressure (hypertension), high cholesterol (hypercholesterolemia), high blood sugar (hyperglycemia), metabolic syndrome, obesity, management of certain debilitating conditions, such as low back pain (sciatica), shoulder, ankle and knee complaints, chronic fatigue, etc.

- 3.2. To ensure that the equipment is properly positioned and always stored correctly in order to reduce the risk of injury
- 3.3. To ensure that the equipment is properly utilized and the exercises performed correctly by staff using the facility
- 3.4. To provide safe, appropriate and individualized training programs for staff in order to ensure that staff exercise within their limits of tolerance and level of physical fitness, so as not to overexert themselves and cause delayed or prolonged muscle soreness and/or fatigue
- 3.5. To ensure that staff members are properly screened physically and clinically before being allowed to exercise in order to prevent any medical emergencies nom happening;
- 3.6. To ensure that staff members classified as being at high risk (for contracting and emergency heart attack) are properly referred to medical support

- 3.2 Preference points hall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts.
- 3.3 Points scored will be rounded off to 2 [two] decimal places.
- 3.4 In the event of equal points scored, the Bid will be awarded to the Bidder scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more Bids have scored equal points including equal preference points for B-BBEE, the successful Bid will be the one scoring the highest score for functionality.
- 3.6 Should two or more Bids be equal in all respect, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

4.1 In terms of Regulation 5(2) and 6(2) of the Preferential Procurement Regulations, 2011, preference points shall be awarded to a Bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 4.3 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auctors to not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EME's with B-BBEE Status Level Certificates.
- 4.4 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 4.5 A trust, consortium or joint venture will qualify for points for its B-BBEE status level as a legal entity, provided that the entity submits its B-BBEE status level certificate.
- 4.6 A trust, consortium of joint venture will qualify for points for their B-BBEE status level as an unincorporated entity provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 4.7 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialised scorecard contained in the B-BBEE Codes of Good Practice.
- 4.8 A person will not be awarded points for B-BBEE status level if it is indicated in the Bid documents that such a Bidder intends subcontracting more than 25% [twenty-five per cent] of the value of the contract to any other enterprise that does not qualify for at least the same number of points that such a Bidder qualifies for, unless the intended subcontractor is an EME that has the capability and ability to execute the subcontract.
- 4.9 A person awarded a contract may not subcontract more than 25% [twenty-five per cent] of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.
