- Refrigerated trucks (0°C 4°C) must be used to transport fresh, frozen and processed food to enforce cold chain management.
- Temperatures will be monitored on all incoming products.
- Records of thermographs and cold chain management to be produced on request
- Staff delivering the products must wear clean uniforms and safety shoes.
- Products that are not in the correct temperature on delivery will be returned immediately.
