- 1.1 A total of 20 preference points shall be awarded for B-BBEE Status Level of Contribution.
- 1.2 Failure on the part of a Bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System [SANAS] are a Registered Auditor approved by the Independent Regulatory Board of Auditors [IRBA] or an Accounting Officer as contemplated in the Close Corporation Act [CCA] together with the bid will be interpreted to mean that preference points for B-BBEE Status Level of Contribution are not claimed.

- 2.7 "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of contract.
- 2.8 "contract" means the agreement that results from the acceptance of a bid by Transnet;
- 2.9 **"EME"** means any enterprise with an annual total revenue of R5 [five] million or less as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with an annual total revenue of R10 [ten] million or less as per the Revised Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928;
- 2.10 "firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease
- 2.11 resulting from the change, imposition, or abolition of customs and excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any
- 2.12 supplies, or the rendering costs of any service, for the execution of the contract;



- 2.13 "functionality" means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.14 "non-firm prices" means all prices other than "firm" prices;
- 2.15 "person" includes reference to a juristic person;
- 2.16 "QSE" means any enterprise with an annual total revenue between R5 [five] million and R35 [tinkty five] million as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with all annual total revenue of between R10 [ten] million and R50 [fifty] million as per the Revised Codes of Good Practice is seed on 11 October 2013 in terms of Government Gazette No. 36928
- 2.17 "rand value" means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.18 "subcontract" means the primary contractor's assigning or leasing or making out work to, or employing another person to support such primary contractor in the execution of part of a project in terms of the contract;

The domicilium citandi et executance hall be a place in the Republic of South Africa to be specified by the Respondent in its Pid at which all legal documents may be served on the Respondent who shall agree to submit to the julisdiction of the courts of the Republic of South Africa. - Blacklisting is a mechanism used to exclude a company/person from future business with Transnet for a specified period. The decision to blacklist is based on one of the grounds for blacklisting. The standard of proof to commence the blacklisting process is whether a "prima facie" (i.e. on the face of it) case has been established.
- Depending on the seriousness of the misconduct and the strategic importance of the Goods/Services, in addition to blacklisting a company/person from future business, Transnet may decide to terminate some or all existing contracts with the company/person as well.
- A supplier or contractor to Transnet may not subcontract any partion of the contract to a blacklisted company.
- 32.5 Grounds for blacklisting include: If any person/Enterprice which has submitted a Bid, concluded a contract, or, in the capacity of agent or subcontractor, has been associated with such Bid or contract:
- a) Has, in bad faith, withdrawn such Bid after the tien ed closing date and time for the receipt of Bids;
- b) has, after being notified of the acceptance of his old, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the bid documents;
- c) has carried out any contract leading from such bid in an unsatisfactory manner or has breached any condition of the contract
- d) has offered, promise or goes a bribe in relation to the obtaining or execution of the contract;
- e) has acted in a calculated or improper manner or in bad faith towards Transnet or any Government Department or towards any public body, Enterprise or person;
- f) he de any incorrect statement in a certificate or other communication with regard to the Service or hir B-BBEE status and is unable to prove to the satisfaction of Transnet that:
- (i) he made the statement in good faith honestly believing it to be correct; and
- (ii) before making such statement he took all reasonable steps to satisfy himself of its correctness;
- g) caused Transnet damage, or to incur costs in order to meet the contractor's requirements and which could not be recovered from the contractor;
- h) has litigated against Transnet in bad faith.
- Transnet recognizes that trust and good faith are pivotal to its relationship with its suppliers. When a dispute arises between Transnet and its supplier, the parties should use their best endeavours to resolve the dispute in an amicable manner, whenever possible. Litigation in bad faith negates the principles of

- 32.7 trust and good faith on which commercial relationships are based. The decision to extend the blacklist to associated companies will be at the sole discretion of Transpet.
- Any per transfer or company against whom a decision to blacklist has been taken, may make representations to the Chief Financial Officer of Transnet SOC Ltd, whose decision shall be final.

 - c) hospitality packages do not exceed R5 000 in value or many low value hospitality packages do not curve la ively exceed R5 000;
 - d) Adder / Supplier does not give a Transnet employee more than 2 (two) gifts within a 12 (two) month period, irrespective of value;
 - a bidder / Supplier does not accept more than 1 (one) gift in excess of R750 (seven hundred and fifty Rand) from a Transnet employee within a 12 (twelve) month period, irrespective of value;
 - a Bidder / Supplier may under no circumstances, accept from or give to, a Transnet employee any gift, business courtesy, including an invitation to a business meal and /or drinks, or hospitality package, irrespective of value, during any bid evaluation process, including a period of 12 (twelve) months after such tender has been awarded, as it may be perceived as undue and improper influence on the evaluation process or reward for the contract that has been awarded; and
 - g) a Bidder / Supplier may not offer gifts, goods or services to a Transnet employee at artificially low prices, which are not available to the public at those prices.



16.3 The Bidder / Supplier will not collude with other parties interested in the contract to preclude a competitive bid price, impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract. The Bidder / Supplier further commits itself to delivering against all agreed upon conditions as stipulated within the contract.

The Bidder / Supplier will not enter into any illegal or dishonest agreement or understanding, whether formal or informal with other Bidders / Suppliers. This applies in particular to certification submissions or non-submission of documents or actions that are restrictive or to introduce carrely into the bidding process

- 16.4 The Bidder / Supplier will not commit any criminal offence under the relevant anti-corruption laws of South Africa or any other country. Furthermore, the Bidder /Supplier will not use for illegitimate purposes or for restrictive purposes or personal gain, or pass on to others, any information provided by Transnet as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- 16.5 A Bidder / Supplier of foreign origin shall disclose the name and address of its agents or representatives in South Africa, if any, involved directly or indirectly in the registration or bidding process. Similarly, the Bidder / Supplier of Social African nationality shall furnish the name and address of the foreign principals, if any, involved directly or indirectly in the registration or bidding process.
- **16.6** The Bidder / Supplier will not misrepresent lests of furnish false or forged documents or information in order to influence the bidding process to the advantage of the Bidder / Supplier or detriment of Transnet or other competitors.
- 16.7 The Bidder / Supplier shall forms to Transnet with a copy of its code of conduct, which code of conduct shall reject the use of bhorse and other dishonest and unethical conduct, as well as compliance programme for the happy mentation of the code of conduct.
- **16.8** The Bidder / Supplier will not instigate third persons to commit offences outlined above or be an accessory a such offences.

17 INDEPENDENT BIDDING

- 17.1 For the purposes of that Certificate in relation to any submitted Bid, the Bidder declares to fully understand that the word "competitor" shall include any individual or organisation, other than the bidder, whether or not affiliated with the Bidder, who:
 - a) has been requested to submit a Bid in response to this Bid invitation;
 - b) could potentially submit a Bid in response to this Bid invitation, based on their qualifications, abilities or experience; and
 - provides the same Goods and Services as the Bidder and/or is in the same line of business as the Bidder.
- **17.2** The Bidder has arrived at his submitted Bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium will not be construed as collusive bidding.





- **17.3** In particular, without limiting the generality of paragraph 5 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - a) prices;
 - b) geographical area where Goods or Services will be rendered [market allocation];
 - c) methods, factors or formulas used to calculate prices;
 - d) the intention or decision to submit or not to submit, a Bid;
 - e) the submission of a Bid which does not meet the specifications and conditions of the RFP; or
 - f) bidding with the intention of not winning the Bid.
- 17.4 In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions of derivery particulars of the Goods or Services to which his/her Bid relates.
- 17.5 The terms of the Bid as submitted have not been, and will no be, d'sclosed by the Bidder, directly or indirectly, to any competitor, prior to the date and time of the official Bid opening or of the awarding of the contract.
- 17.6 Bidders are aware that, in addition and without periodice to any other remedy provided to combat any restrictive practices related to bids and ontraits, Rids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act to 89 of \$2.8 and/or may be reported to the National Prosecuting Authority [NPA] for criminal investigation and/or may be restricted from conducting business with the public sector for a period not exceeding 10 [ten] years in terms of the Prevention and Combating of Corrupt Activities Act No 12 \$20.4 or any other applicable legislation.
- 17.7 Should the Bidder find any teams or conditions stipulated in any of the relevant documents quoted in the RFP unacceptable at should indicate which conditions are unacceptable and offer alternatives by written submission on the company letterhead, attached to its submitted Bid. Any such submission shall be subject to be the by Transnet's Legal Counsel who shall determine whether the proposed alternative(s) respectively.

18 DISQUALTICATION FROM BIDDING PROCESS

- 18 ft & Bidder / Supplier has committed a transgression through a violation of section 3 of this Integrity act or in any other form such as to put its reliability or credibility as a Bidder / Supplier into question, Transnet may reject the Bidder's / Supplier's application from the registration or bidding process and remove the Bidder / Supplier from its database, if already registered.
- 18.2 If the Bidder / Supplier has committed a transgression through a violation of section 3, or any material violation, such as to put its reliability or credibility into question. Transnet may after following due procedures and at its own discretion also exclude the Bidder / Supplier from future bidding processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, which will include amongst others the number of transgressions, the position of the transgressors within the company hierarchy of the Bidder / Supplier and the amount of the damage. The exclusion will be imposed for up to a maximum of 10 (ten) years. However, Transnet reserves the right to impose a longer period of exclusion, depending on the gravity of the misconduct.



18.3 If the Bidder / Supplier can prove that it has restored the damage caused by it and has installed a suitable corruption prevention system, or taken other remedial measures as the circumstances of the case may require, Transnet may at its own discretion revoke the exclusion or suspend the imposed penalty.

19 TRANSNET'S LIST OF EXCLUDED TENDERERS (BLACKLIST)

- **19.1** All the stipulations around Transnet's blacklisting process as laid down in Transnet's Supply Chain Policy and Procurement Procedures Manual are included herein by way of reference. Below follows a condensed summary of this blacklisting procedure.
- **19.2** Blacklisting is a mechanism used to exclude a company/person from future business with Transnet for a specified period. The decision to blacklist is based on one of the grounds for blacklisting. The standard of proof to commence the blacklisting process is whether a **Drimes facie** (i.e. on the face of it) case has been established.
- 19.3 Depending on the seriousness of the misconduct and the strategy importance of the Goods/Services, in addition to blacklisting a company/person from future business, Transnet may decide to terminate some or all existing contracts with the company/person as tell.
- **19.4** A supplier or contractor to Transnet may not subcentract any portion of the contract to a blacklisted company.
- **19.5** Grounds for blacklisting include: If any perton/Enterprise which has submitted a Bid, concluded a contract, or, in the capacity of agent or abcontractor, has been associated with such Bid or contract:
 - i) Has, in bad faith, with read such Bid after the advertised closing date and time for the receipt of Bids;
 - j) has, after feing notified of the acceptance of his Bid, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the bid documents;
 - k) has a trie out any contract resulting from such bid in an unsatisfactory manner or has treached any condition of the contract;
 - 1) has vered, promised or given a bribe in relation to the obtaining or execution of the contract;
 - has acted in a fraudulent or improper manner or in bad faith towards Transnet or any Government Department or towards any public body, Enterprise or person;
 - n) has made any incorrect statement in a certificate or other communication with regard to the Local Content of his Goods or his B-BBEE status and is unable to prove to the satisfaction of Transnet that:
 - (iii) he made the statement in good faith honestly believing it to be correct; and
 - (iv) before making such statement he took all reasonable steps to satisfy himself of its correctness;
 - o) caused Transnet damage, or to incur costs in order to meet the contractor's requirements and which could not be recovered from the contractor;
 - p) has litigated against Transnet in bad faith.

- **19.6** Grounds for blacklisting include a company/person recorded as being a company or person prohibited from doing business with the public sector on National Treasury's database of Restricted Suppliers or Register of Tender Defaulters.
- 19.7 Companies associated with the person/s guilty of misconduct (i.e. entities owned, controlled or managed by such persons), any companies subsequently formed by the person(s) guilty of the misconduct and/or an existing company where such person(s) acquires a controlling stake may be considered for blacklisting. The decision to extend the blacklist to associated companies will be at the sole discretion of Transnet.

20 PREVIOUS TRANSGRESSIONS

- **20.1** The Bidder / Supplier hereby declares that no previous transgressions recultive in a serious breach of any law, including but not limited to, corruption, fraud, theft exception and contraventions of the Competition Act 89 of 1998, which occurred in the last 5 (ive) years with any other public sector undertaking, government department or private sector company that lould justify its exclusion from its registration on the Bidder's / Supplier's database or any didding process.
- 20.2 If it is found to be that the Bidder / Supplier made in incorrect statement on this subject, the Bidder / Supplier can be rejected from the registration places or removed from the Bidder / Supplier database, if already registered, for such reason (refer to the breach of Law Form contained in the applicable RFX document.

21 SANCTIONS FOR VIOLATIONS

- **21.1** Transnet shall also true all only one of the following actions, wherever required to:
 - a) Immediately exclude the bidder / Supplier from the bidding process or call off the pre-contract negotiations without bing any compensation the Bidder / Supplier. However, the proceedings with the other bidders / Suppliers may continue;
- b) Immedia ely cincel the contract, if already awarded or signed, without giving any compensation to the idde //Supplier;
- ever all sums already paid by Transnet;
- dy Incash the advance bank guarantee and performance bond or warranty bond, if furnished by the Sidder / Supplier, in order to recover the payments, already made by Transnet, along with interest;
- e) Cancel all or any other contracts with the Bidder / Supplier; and
- f) Exclude the Bidder / Supplier from entering into any bid with Transnet in future.

22 CONFLICTS OF INTEREST

- **22.1** A conflict of interest includes, inter alia, a situation in which:
- a) A Transnet employee has a personal financial interest in a bidding / supplying entity; and
- b) A Transnet employee has private interests or personal considerations or has an affiliation or a relationship which affects, or may affect, or may be perceived to affect his / her judgment in action in the best interest of Transnet, or could affect the employee's motivations for acting in a particular manner, or which could result in, or be perceived as favouritism or nepotism.



- 22.2 A Transnet employee uses his / her position, or privileges or information obtained while acting in the capacity as an employee for:
- a) Private gain or advancement; or
- The expectation of private gain, or advancement, or any other advantage accruing to the employee b) must be declared in a prescribed form.
 - Thus, conflicts of interest of any bid committee member or any person involved in the sourcing process must be declared in a prescribed form.
- 22.3 If a Bidder / Supplier has or becomes aware of a conflict of interest i.e. a famile, business and / or social relationship between its owner(s) / member(s) / director(s) / partner(s) / si reholder(s) and a Transnet employee / member of Transnet's Board of Directors in respect of a bid which will be considered for the bid process, the Bidder / Supplier:
 - COP must disclose the interest and its general nature, in the Reguest for 'RFX") declaration form:
 - b) must notify Transnet immediately in writing once the circumstances ha s arisen.
- 22.4 The Bidder / Supplier shall not lend to or borrow any maney from or enter into any monetary dealings or transactions, directly or indirectly, with any commune member or any person involved in the sourcing process, where this is done, Transnet stall be entitled forthwith to rescind the contract and all other contracts with the Bidder / Supplier.

MONITORING 23

- 23.1 Transnet will be responsible for all pointing an independent Monitor to:a) Conduct random monitoring of conspliance to the provisions of this Integrity Pact for contracts entered into between Transp and Bidder / Supplier for less than R100,000.000 (one hundred million Rand) in value;
 - Monitor compliants to the rovisions of this Integrity Pact for contracts entered into between Transnet and the Bidder Supplier for greater than R100,000.000 (one hundred million Rand) in value; and
 - Invest at any anegation of violation of any provisions of this Integrity Pact for contracts entered into between transfet and the Bidder / Supplier, irrespective of value.
- violinger will be subjected to Transnet's Terms of Conditions of Contract for the Provision of ervices to Transnet, as well as to Transnet's Supplier Code of Conduct.

EXAMINATION OF FINANCIAL RECORDS, DOCUMENTATION AND/OR ELECTRONIC DATA

For the purpose of Monitoring, as stipulated above, the Monitor shall be entitled to:

Examine the financial records, documentation and or electronic date of the Bidder / Supplier / Transnet. The Bidder / Supplier / Transnet shall provide all requested information / documentation / data to the Monitor and shall extend all help possible for the purpose of such examination.



25 DISPUTE RESOLUTION

- **25.1** Transnet recognises that trust and good faith are pivotal to its relationship with its Bidders / Suppliers. When a dispute arises between Transnet and its Bidder / Supplier, the parties should use their best endeavours to resolve the dispute in an amicable manner, whenever possible. Litigation in bad faith negates the principles of trust and good faith on which commercial relationships are based. Accordingly, following a blacklisting process as mentioned in paragraph 19 above, Transnet will not do business with a company that litigates against it in bad faith or is involved in any action that reflects bad faith on its part. Litigation in bad faith includes, but is not limited to the following instances:
 - a) Vexatious proceedings: these are frivolous proceedings which have been instituted without proper grounds;
 - b) **Perjury:** where a supplier make a false statement either in giving exidence or an affidavit;
 - c) **Scurrilous allegations:** where a supplier makes allegations regarding a senior Transnet employee which are without proper foundation, scandalous, abusiv or defamatory; and
 - d) **Abuse of court process:** when a supplier abuses the rourt process in order to gain a competitive advantage during a bid process.

26 GENERAL

- **26.1** This Integrity Pact is governed by an interpretarin accordance with the laws of the Republic of South Africa.
- **26.2** The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the providions of the law relating to any civil or criminal proceedings.
- **26.3** The validity of this Three ity Pact shall cover all the bidding processes and will be valid for an indefinite period unless cancelled by eather Party.
- **26.4** Should one in several provisions of this Integrity Pact turn out to be invalid the remainder of this Integrity Pact remains valid.
- Sound a Bidder / Supplier be confronted with dishonest, fraudulent or corruptive behaviour of one or nore Transnet employees, Transnet expects its Bidders / Suppliers to report this behaviour directly to assenior Transnet official / employee or alternatively by using Transnet's "Tip-Off Anonymous" hotline number 0800 003 056, whereby your confidentiality is guaranteed.

The Parties hereby declare that each of them has read and understood the clauses of this Integrity Pact and shall abide by it. To the best of the Parties' knowledge and belief, the information provided in this Integrity Pact is true and correct.
