EARTH MOVING EQUIPMENT LEASE FOR 1 WEEK AT VEREENIGING DEPOT SPECIAL CONDITIONS OF CONTRACT

1. SCOPE OF WORK

The below requested machines are required to level the service road using material between Union and Skansdam.

The following plants are required:

Equipment description

- Grader 140
- TLB 422E
- 10m³ Tipper Truck

2. AREA OF OPERATIONS

The area of operations shall be within the eserve controlled by the Vereeniging depot engineer including: -

Union - Skansdam

3. WORKING HOURS

The normal working tooks for this contract shall be between 07:30 and 16:00, with a half hour break between 12:00 and 12:30 daily.

4. **ESCALATION**

All increases in costs from whatsoever cause shall be at the Contractor's risk and for his account.

5. VALUE ADDED TAX

Value Added Tax at the ruling percentage shall be paid as per Contractors invoice.

6. **INSURANCE**

It shall be the responsibility of the Contractor to arrange for any insurance cover or additional insurance cover for his machine, facilities and staff. Transnet Freight Rail will not consider a claim for loss, death, injury or damage from any cause whatsoever.

7. ACCOMMODATION

No accommodation of any description will be provided by Transnet Freight Rail for the Contractor's use. Accommodation and transportation to and from work sites is for the contractors account.

MOVEMENT OF PLANT

Movement to and from site shall be as directed by Transnet Freight Rail and will be arranged by Transnet Freight Rail.

10. SERVICING AND MAINTENANCE

The Contractor shall provide all material, tools and equipment necessary for the servicing and maintenance of his plant and shall carry out the servicing and maintenance at his own expense and in his own time.

11. DURATION OF CONTRACT

The contract period will be 1 week from the date that the Contractor is notified of the acceptance of his tender. The contract will have a limiting value of as stated by Transnet and the contract period will be such that the value is not exceeded.

12. SITE DOCUMENTATION

The Contractor shall supply a duplicate carbon copy book with detachable numbered sheets. This logbook must stay with the Contractor's plant at all times. A daily log of hours worked and breakdowns shall be tent, each day on a separate sheet. The Contractor must ensure that the logshees are signed and date stamped by the Site Supervisor or Engineer before submitting such documentation for payment.

13. CANCELLATION OR REMOVAL OF THE PLANT FROM SITE

If, in the opinion of Transnet Freight Rall, the operator or the output of the plant is unsatisfactory, Transnet Freight Rall reserves the right to:-

- (i) cancel the contract
- (ii) order the removal of the operator
- (iii) order the removal, imporarily or permanently, of the particular item of plant, or its replacement.

14. MECHANICAL CONDITION

Transnet Freight Rail reserves the right to inspect all plant offered as well as the maintenance infrastructure offered prior to the awarding of the contract. All plant offered should be either (1) not older than 5 years, or (2) have been reconditioned within the last 5 years.

* Copies of vehicle registration documents are to accompany tender documents (Logbook, COF certificate and service book for the plants).

15. STANDING TIME

When the Contractor has been ordered to work, and if the plant is available for work but is not working due to a requirement, act or omission on the part of Transnet Freight Rail or any other Contractor working for Transnet Freight Rail, the Contractor will be paid standing time:

- (i) only for time falling within the hours of duty specified;
- (ii) only when the plant is in full working order.

The time claimed as standing time must be certified by an authorised representative of Transnet Freight Rail.

18. PAYMENT

- 18.2 Payment will be made per hour or part thereof that the plant is in the possession of Transnet Freight Rail, provided that the plant is in a fully operational condition.
- 18.3 The rates quoted in the Schedule of Prices shall be inclusive of all costs in the supply and maintenance in a fully operational condition of the plant.
