Transnet SOC Limited trading as Transnet Freight Rail invites tenders For The Maintenance and Repair of various buildings in Ermelo.

Only those tenderers who are registered with the CIDB, or capable of being so prior to evaluation of submissions, in a contractor grading designation equal to **3GB or 2GB PE and 3EP or 2EP PE** or higher than a contractor grading designation determined in accordance with the sum tendered or a value determined in accordance with regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a **3GB or 2GB PE and 3EP or 2EP PE** or higher class of construction work, are legible to have their tenders evaluated.
