#### 3 Broad-Based Black Economic Empowerment [B-BBEE]

#### 11.1 INTRODUCTION

Komatipoort Fuel Facility is located at Nkomazi Local Municipality in Mpumalanga Province following location: Latitude S: 25° 26′ 12.52″ Longitude E: 31° 57′ 06.90″

- 11.1.1 All quantities are provisional, are an indication of the extent and type of work to be executed and have been inserted in order to obtain competitive tenders. All work carried out under this contract shall be measured and valued at schedule rates and in accordance with the Conditions of Contract.
- 11.1.2 The prices and rates to be inserted in the schedules are to be full inclusive prices to the Employer for the work described under each item. Such prices shall cover all costs and expenses that may be required in and for the Repairs of the work described and shall cover the costs of all taxes (except VAT), general risks, liabilities and obligations set forth or implied in the documents on which the RFQ is based. The amount of VAT to be charged is to be stated separately in the Summary Page of the Schedule of Rates.
- 11.1.3 No alteration, erasure or addition is to be made in the text of the schedules of rates. Should any alteration, erasure or addition be made it will not be recognised but the original wording of the schedule of rates will be adhered to.

11.1.4 Any provisional sums shall be measured as executed and paid for according to prices in the schedule of rates. No work from which Provisional items are provided shall be commenced without written (PMI) instructions from the Project Engineer.

#### **11.2** The following summarizes Komatipoort Fuel Facility ATG repairs scope of work:

11.2.1 Replace the ATG's impulse lines that were cut with new impulses on the three (3) horizontal tank ATG's,

Impulse line OD = should be 6mm stainless steel tubing with approximately 210m long with bends

11.2.2 Supply and install new alarms system on the three (3) horizontal tanks. Remove the old alarm system currently installed

#### 11.2.2.1 The alarm capability should be as flows:

- HH= 85% audible with 112 decibels
- H = 75% audible with 112 decibels
- LL = 15% audible with 112 decibels
- Red flashing light whenever the alarm sound (visible indicator)

#### 12 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

### 13 Security clearance

#### 15 Tax Compliance
