- not necessarily accept the lowest priced Quotation or an alternative bid;
- reject all Quotations, if it so decides;
- place an order in connection with this Quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / service/s which are reflected in the scope of this RFQ;

- 11.1.7 Calibrate the flowmeters on refuelling station A, and issue valid calibration certificates (SANAS Approved).
