2 Broad-Based Black Economic Empowerment [B-BBEE]

Note: Failure to submit a valid and original B-BBEE certificate or a certified copy thereof at the Closing Date of this RFQ will result in a score of zero being allocated for B-BBEE.

10 SPECIFICATION/SCOPE OF WORK

Scope of work:

Transnet Freight Rail requires the drousion of an efficient <u>erf</u> cleaning and clearing service to various TFR sites situated at Swartkops, Redhouse, Stuenham, Deal Party and New Brighton in Port Elizabeth over a period of 24 months. The successful service provider will have to supply the material, labour, transport and consumables of any description, which may be necessary for the proper completion of the contract work, in accordance with the specifications as follows:

Site Information

The sites consist of the following areas:

Port Elizabeth:

- Swartkops Diesel Depot erf no SPX 0336E= 43 300 m²
- Swartkops Electric Depot erf no SPX 0288E=8 500 m²
- Redhouse erf no KSX 0544E=24 000 m²
- New Brighton shunting yard erf no SPX 0142 = 250 000 m²
- Sydenham erf no SPX 0490 = 70 000 m²
- Deal Party erf no SPX 0179 = 68 000 m²

Note: Services will be required as follows:

- Swartkops Diesel and Electric Depot: Sites to be serviced twice per year over a period of 24 months = 4 services
- 2. Redhouse: Site to be serviced 4 times per year over a period of 24 months = 8 services
- 3. New Brighton: Site to be serviced 6 times per year over a period of 24 months = 12 services
- 4. Sydenham & Deal Party: Site to be serviced twice per year over a period of 24 months = 4 services

PARTICULAR SPECIFICATION

• CLEANING AND CLEARING:

The works include the following:

- All bushes and trees up to 75mm diameter to be cut off as close to 100mm above ground level as possible.
- All other grass and overgrowth to be cut to a height of not more than 80mm above ground level.
- o All trees/shrubs to be trimmed 2m above ground level
- o All trimming around paths, edges and around all structures i.e. buildings and fences.
- Clean/clear boundary fences on Transnet side from overgrowing vegetation at Deal Party only
- o The site shall be cleaned of all litter such as paper, rubble, and tins, plastic and other debris
- All material, rubbish, litter and rubble must be removed from site and transported and dumped at an approved municipality dumpsite

INCOMPETENT EMPLOYEES

Any person employed by the contractor on the Works, who is, in the opinion of the Project Manager incompetent, or who may act in such an improper manner, may be discharge from the works by the Project Manager. Such a person shall not again be employed on the works without the permission of the Project Manager.

DRAWINGS:

Site plans of sites are attached as annexure D.

• TIME TO COMPLETE THE WORK

- The contractor shall indicate herein the duration he requires to complete the work per service to the site, but the period shall be preferred to be not be longer than 30 (thirty) working days.
- The contractor shall be required to complete the rock per service in this period, as given. This period excludes weekends, public holidays and faturery holiday periods.
- Failing completion of the work within the period as stoudted above or with any period offered by the contenders and accepted by Transnet, the contractor shall pay to Transnet as penalty the sum of R 500.00 (five hundred rand) for every day or part thereof during which the works remain incomplete.

• RISK ASSESSMENT:

- # Employees of contractor to wear safety vest at all times on the site.
- # Employees of contractor to wear safety foot protection on the site.
- # Employees of contractor to wear eye and ear protection when working with weed cutters and chainsaws.
- # No open fires are allowed on the site.
- # The successful contractor must submit a complete safety file and a copy must be submitted to Transnet (Project Manager) for safe keeping and further reference
- # The contractor shall provide full time supervisor on the site.
- # Site diary must be kept daily and be on site at all times.
- # All plant operators to be trained on plant that he/she is operating.
- # All work to be carried out in accordance to the health and safety act.
- # Medical Surveillance Certificates of Fitness Records will be required.
- # A safety induction will be conducted with the successful bidder by TFR before any contract work can commence.

• SITE RECORDS:

Site Diary

The Contractor shall provide a diary, in triplicate to record all day-to-day incidents that could occur during the contract period. This includes weather, name & number of workers on the site, material that has been delivered, material that has been loaded and disposed of, incidences that have occurred, what work is to be done on that day, etc.

Program & Planning of the work

The contractor shall provide to the manager a detail plan of how he intends to do the work and this plan must be to the requirements of the operation of Transnet freight rail with minor disruptions as no delays must be allowed in this regard.

The program must be agreed to (in the site instruction book) before any work will be allowed to commence. The program may be in a form of a pert (bar) chart and will be used as a guide to measure progress of the work.

ACCESS TO SITE

The areas are restricted and the contractor must ensure he complies with the regulations of Transnet freight rail in every way. Contractor and/or any sub-contractors shall be required to apply for permission to enter the restricted area in writing. A list of workmen shall be given to the Project Manager to arrange for the necessary permitre. 48 lours minimum notice is necessary for the processing these permits. This includes changes to seff any age the contract period.

MATERIALS FOUND ON STE

The Contractor shall not use on the works any materials found on the site without the prior written consent of the manager. No material that is lying on the site (other than that from this contract) or on Transnet freight rail's property may be removed everyifteemed as scrap) by the contractor.

No scrap or any material of value may be removed from the site without written authority of the Project Manager.

• CLEARING OF SITE

The Contractor shall provide for cleaning up and sorting air rubbish and debris of whatever kind throughout the duration of the contract. Upon completion the Contractor shall clear away and remove all rubbish, unused material, plant and debris and leave the site and the whole of the works clean and tidy to the satisfaction of the Project Manager.

ESCALATION

This contract does not make provision for compensation in respect of increased costs. The contenders must allow in his fixed price for any increased costs, which he may encounter during the contract period or such extended period as agreed upon by both parties.

SAFETY PRECAUTIONS AND INSURANCE

Damage to Transnet freight rail Assets and liability, the contractor shall provide the insurance for the following: -

1. INTRODUCTION

- 1.1 A total of 20 preference points shall be awarded for B-BBEE Status Level of Contribution.
- 1.2 Failure on the part of a Bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System [SANAS] or a Registered Auditor approved by the Independent Regulatory Board of Auditors [IRBA] or an Accounting Officer a contemplated in the Close Corporation Act [CCA] together with the bid will be interpreted to mean pracopreference points for B-BBEE Status Level of Contribution are not claimed.
- 1.3 Transnet reserves the light to require of a Bidder, either before a Bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by Transnet.

2. GENERAL DEFINITIONS

- 2.1 **"all applicable taxes"** include value-added tax pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;

- 2.6 **"comparative price"** means the price after the factors of a non-firm price and all unconditional discounts that can utilised have been taken into consideration;
- 2.7 "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract;
- 2.8 "contract" means the agreement that results from the acceptance of a bid by Transnet;

- 2.9 "EME" means any enterprise with an annual total revenue of R5 [five] million or less as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with an annual total revenue of R10 [ten] million or less as per the Revised Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928;
- 2.10 "firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs and excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 "functionality" means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 "non-firm prices" means all prices other than "firm" prices;
- 2.13 "person" includes reference to a juristic person;
- 2.14 "QSE" means any enterprise with an annual total revenue between R5 [five] million and R35 [thirty five] million as per the 2007 version of the B-BBEE Codes of Good Practice and means any enterprise with an annual total revenue of between R10 [ten] million and R50 [fifty] million as per the Revised Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928
- 2.15 "**rand value**" means the total estimate value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.16 **"subcontract"** means the primary contractor's assigning or leasing or making out work to, or employing another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.17 **"total revenue"** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Empowerment Act and promulgated in the Government Gazette on 9 February 2007;
- 2.18 **"trust"** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.19 **"trustee"** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The Bidder obtaining the highest number of total points for the evaluation criteria as enumerated in Section 2 of the RFP will be awarded the contract, unless objective criteria justifies the award to another bidder.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts.
- 3.3 Points scored will be rounded off to 2 [two] decimal places.

- 3.4 In the event of equal points scored, the Bid will be awarded to the Bidder scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more Bids have scored equal points including equal preference points for B-BBEE, the successful Bid will be the one scoring the highest score for functionality.
- 3.6 Should two or more Bids be equal in all respect, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

- 4.2 Bidders who qualify as EMEs in terms of the 2007 version of the Codes of Good Practice must submit a certificate issued by an Accounting Officer is contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of contucting verification and issuing EME's with B-BBEE Status Level Certificates.
- 4.3 Bidders who qualify as EMEs in terms of the Revised Codes of Good Practice issued on 11 October 2013 in terms of Government Gazette No. 36928 are only required to obtain a sworn affidavit on an annual basis confirming that the entity has an Annual Total Revenue of R10 million or less and the entity's Level of Black ownership.
- In terms of the 2007 version of the Codes of Good Practice, Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 4.5 The Department of Trade and Industry recently revised the Codes of Good Practice on 11 October 2013 [Government Gazette No. 36928]. - 4.9 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 4.10 Tertiary institutions and subject entities will be required to submit their B-BBEE status level certificates in terms of the specialised segrecard contained in the B-BBEE Codes of Good Practice.
- 4.11 A person will not be awarded points for B-BBEE status level if it is indicated in the Bid documents that such a Bidder intends subcontracting more than 25% [twenty-five per cent] of the value of the contract to any other enterprise that local not qualify for at least the same number of points that such a Bidder qualifies for, unless the intended subcontractor is an EME that has the capability and ability to execute the subcontract.
